- 3. I am aware that Tenants will not be allowed access to the Estate unless all administration and notification requirements, as outlined in this form, have been complied with;
- 4. I am aware that every Tenant (and all adults that occupy through a Tenant) must report to the office within 1 Business Day of arrival in the Estate;

- 5. I am aware that I may not let any area in the House/Unit for storage or other non-residential purposes, unless it is a lease of a surplus garage or storage space in a sectional title unit, to another owner of a House/Unit in the Estate;
- 6. I am aware that no more than 2 people per bedroom may occupy the House/Unit at any time;
- 7. I am aware that I may not lease any space in the House/Unit for a period of less than 10 continuous days;
- 8. I have paid the annual Tenant Administration Fee to the Association for the House/Unit for the current financial year;
- 9. I am aware that Tenant Registrations will only be approved if -
 - I have paid the required annual Tenant Administration Fee, for the House/Unit in question, during the calendar year in question;
 - b. the Tenant has signed a Tenant Declaration and the signed and properly completed form has been delivered to the Greenways office; and
 - c. in the case of a long-term (more than 6 months) Tenant, a copy of my written lease agreement with the Tenant has been lodged with the office of the Estate Manager.
- 10.1 am aware that I am responsible for all acts and omissions of all Tenants and all resultant fines, including speeding fines;
- 11.I am aware that no Tenant may sub-lease any space in any House/Unit;
- 12.I am aware that all letting agents must have a written mandate and that a copy of a valid mandate for the House/Unit must be filed with the Greenways office;
- 13.I am aware that access to the Estate may be denied to Tenants or members of their household or their invitees, employees or guests should the Tenant or anyone for whom the Tenant is responsible contravene any provision of the Conduct Rules, or any other Regulation;
- 14.I am aware that am liable for all acts/omissions and transgressions of my Tenants; and
- 15.I am aware that for as long as any levies in respect of the House/Unit are not paid up, letting of the whole or any part the House/Unit is prohibited.
